Tournament Regulations

- This is a battle of multiple teams, each players scores points for their team. No average Rating restriction
- Each team consists of maximum of 15 players. Points calculated based on 10 Leaders (i.e. sum of top 10 scorers)
- If a player NOT in the player list participated, his/her score will NOT be counted
- All players must join zoom with correct setup.
- Each player is accorded a time control of 5 minutes.
- Berserk is allowed
- Arena streaks allowed
- Duration of play is 1 hour if the event has more than 20 teams. If less than 20 teams, duration of play is 1.5 hours

- There will be no sharing of prizes.
